1. Payments **must** be made at the store where you purchased your furniture.
2. **60 days prior to your rotation date**, you **must** pay off the remaining balance on contract. Failure to do so will result in repossession on the purchased items and all monies paid to Yellow Box will be forfeited.
3. Payments must be made on time. You have a **five-day grace period**. Payments due on the first of the month are considered late, if not paid by the fifth then late fees kick in on the sixth of the month. Payments due on the 15th of the month are considered late, if not paid by the 20th then late fees kick in on the 21st of the month.
4. On pre-order contracts, the furniture WILL NOT be delivered until all payments are current. At no time will refunds be issued due to failure to pay. Refunds for early rotation will be considered once you have provided a copy of your new orders stating the new rotation date. Once the furniture is delivered, refunds will not be issued due to early rotation.

5. All shipping dates are **APPROXIMATE**. Pre-orders will **not** be cancelled due to changes in shipping dates. We tell you at the time of purchase the current dates we have and they are always subject to change due to circumstances beyond our control.
6. **The customer, who legal action is taken against, will pay all legal fees that occur in order to collect on this contract or pursue legal action for those who leave the island without paying the monies owed to Yellow Box.**
